

## MINIMUM SAFETY REQUIREMENTS FOR CHEMICAL TANKERS IN TERMINAL

With regard to facility safety and due to the relevant regulations, road tankers without the below specified qualifications and with physical qualities not convenient transport unit and their drivers will not accept to be loaded or unloaded operations in our port.

The rules and practices determined for the vehicles and drivers which are coming to the port for loading / unloading operations are as follows below:

**The following equipment shall be carried on board the transport unit:**



A wheel Chock of a size suited to the maximum mass of the vehicle and to the diameter of the wheel

Safety harness must have CE certificate and in compliance with EN 361:2002 / EN 358: 2009 standards and well-adjusted to the driver and meetings the requirements of its certificate.



Face masks with CE Certificate and in compliance with EN136 / EN 140 standards and filters in compliance with EN 141 / EN 143 standards.



Work Uniform or Overall should be with CE certificate and in compliance with EN464/ EN465 /EN467 standards, in one piece and seam-free. The wear should protect user against chemical material flows and splashing.
